Qantas Founders Museum is a project owned by Qantas Foundation Memorial Ltd (QFM). QFM is independent of Qantas Airways and is a not-for-profit trust company established by the people of Western Queensland to honour the founders of Qantas and to preserve the heritage of Qantas Airways. Even though wholly independent, QFM has been formed with the full support of Qantas Airways. QFM is a member-based corporation and is registered with the Australian Taxation Office as a deductible gift recipient and donations over \$2 are tax deductible.

Over the last 25 years, Qantas Foundation Memorial has supported the development and ongoing growth of Qantas Founders Museum. In that time grants of more than \$22 million from Australian Federal and State Governments and support of more than \$2 million from Qantas have seen the establishment and growth of the museum: Stage 1 based in the original Qantas Hangar; Stage 2 – the completion of the large modern air-conditioned display museum; and Stage 3 – the construction of the airpark roof, providing shelter for our aircraft fleet including the 747 Classic aircraft VH-EBQ, the Boeing 707 aircraft VH-XBA, the Lockheed Super Constellation restored to replicate Qantas Super Constellation L1049 “Southern Spray” VH-EAM, and the Douglas DC-3 aircraft VH-EAP. Luminescent Longreach a 23-minute sound and light show projects on the aircraft at night with plans to expand the films available. Other significant companies and individuals have donated and volunteered their time and expertise towards the preservation of our aviation history.
